

# **Charter School Board Training**

# **Welcome to Minnesota Charter Board Training and Development!**

Minnesota Statutes, section 124E.07, subdivision 7, states: "Every charter school board member shall attend annual training throughout the member's term. All new charter board members shall attend initial training on the board's role and responsibilities, employment policies and practices, and financial management. A new board member who does not begin the required initial training within six months after being seated and complete the training within 12 months after being seated is automatically ineligible to continue to serve as a board member."

Minnesota Statutes do not dictate how many hours or minicourses a board member must complete, but a board member is responsible for knowing all of the statutes reviewed in the minicourses in the three required areas: board role and responsibilities, financial management, and employment policies and practices. For the 2025 legislative session, we urge the legislature to address significant gaps in funding for chartered public-school students, establish a rational policy for charter school facilities, and continue to work proactively with the charter sector on policy issues that enhance accountability while protecting school autonomy.

#### MN SUPREME COURT RULING

This week the MN Supreme Court ruled that Minnesota public schools and local units of government can be held liable for their hiring practices for outcomes that impact student well-being and safety. Context: A lawsuit had been filed against a Minnesota charter school by a student who was sexually assaulted by a staff member, alleging negligent hiring practices. Initially, both the district and appellate courts ruled in favor of the school. The school's legal team argued that hiring decisions were "policy-level decisions," which would exempt them from tort liability under state law. However, this week, the Minnesota Supreme Court overturned these rulings, citing that not every hiring decision is a policy decision, and schools could be liable in certain circumstances. The case has now been sent back to the lower courts for reconsideration.

FEDERAL LEGISLATIVE UPDATES

#### FEDERAL END-DEI PORTAL

This week the U.S. Department of Education introduced <u>EndDEI.Ed.Gov</u>, a portal for reporting discrimination based on race or sex in publicly funded K-12 schools. This initiative aligns with President Trump's executive order to eliminate Diversity, Equity, and Inclusion (DEI) programs within federal agencies. The portal enables parents, students, and teachers to report instances of discrimination, guiding the Department's investigative efforts.

#### DEAR COLLEAGUE LETTER

This week, Commissioner Willie Jett of the Minnesota Department of Education issued further guidance regarding last week's Dear Colleague Letter (DCL) sent to K-12 school leaders. The DCL communicated a shift in the agency's interpretation of federal anti-discrimination laws in K-12 schools. The Department clarified that the letter is not a civil rights enforcement action and explicitly states in its footnotes that it does not have the force and effect of law, nor does it bind the public or create new legal standards. Additionally, the Department emphasized:

- "Federal civil rights enforcement is governed by <u>federal regulations</u> that require ED to take specific steps before freezing or stopping funding."
- "Minnesota state law, including the <u>Minnesota Human Rights Act</u>, prohibits discrimination or preferential treatment in public education on the basis of race, religion, disability, national origin, gender identity and other identities."
- · MDE will continue to seek clarity and work with schools on any changes in guidance on this issue.


