
MN Guild October Newsletter Important Updates

Adding Guild Submission Dates to Your Main Google Calendar



If you use Google Calendar for your normal day-to-day workflow, you may wish to add the Guild submission due dates calendar to your main Google Calendar so you can view them without being logged into

your <u>guildschools.org</u> Google account. We are able to "share" the submissions calendar from your <u>guildschools.org</u> account to your primary account. This will make the calendar appear under "other calendars" on the left sidebar of your Google Calendar screen, and checking/unchecking that box will cause those submission dates to appear/disappear from your calendar screen.

Reminder: 2023 School Behavioral Health Conference Registration

The Minnesota School Behavioral Health Conference is in its seventh year, bringing together collaborating partners and providers to build a school behavioral health framework of community, practice and support. Attendees include schools, community mental health providers, advocates, consumers, policy makers, Tribal Nations, parents/caregivers and state government. The conference provides opportunities to network and learn about the latest developments and best practices related to supporting students with behavioral health needs, their families and the broader school community.

This year's theme is **Impact through Innovation and Empowerment.** This conference seeks to offer attendees purposeful tools and techniques to implement and produce a positive impact on behavioral health and mental well-being. <u>Register for the 2023 School</u> Behavioral Health Conference November 1-3, 2023

Reminder: New Active Transportation Safety Training Requirement

The 2023 Active Transportation Safety Training requirement is effective August 1. All students in public schools must receive age-appropriate education related to safe walking and bicycling during the first few weeks of school. This legislation is similar to the law that requires students to receive bus safety education at the beginning of each school year. The Minnesota Department of Transportation is providing all the resources necessary for schools to be able to meet this new requirement. Visit the Safe Routes to School webpage for more information.

Reminder: Minnesota Youth Water Safety – State Fiscal Year (SFY) 24

A Youth Water Safety grant opportunity is available to Minnesota nonprofit organizations and city and county parks and recreation programs providing swimming lessons to youth. These state funds are available primarily for the purpose of providing low-income and atrisk children with scholarships for swimming lessons based on nationally recognized water safety curricula. Up to 15% of the grant funds may also be used to hire water safety instructors or lifeguards, or to train water safety instructors or lifeguards in nationally recognized water safety practices and instruction. The total funding available is \$250,000 for this fiscal year only (grant ends June 30, 2024). The minimum award is \$10,000 and the maximum award is \$24,000. Completed applications are **due October 20**, 2023. Information and applications can be found on the Minnesota Department of Education Grants webpage for the Minnesota Youth Water Safety grant.

Reminder: FY 2024 Concurrent Enrollment Aid Application – Due October 30

Districts and charter schools offering concurrent enrollment courses in partnership with eligible institutions during the 2023-24 school year are eligible for aid reimbursements per student per course.

 Districts/charters whose partnering institution(s) are not <u>National Alliance of</u> <u>Concurrent Enrollment Partnerships (NACEP)-Accredited Postsecondary Institutions</u> for the 2023-24 School Year, must complete the Concurrent Enrollment Aid

Application 2023-24 in order to receive concurrent enrollment aid. Completed
applications and required documentation must be submitted to MDE no later than

October 30, 2023 for any concurrent courses during the 2023-24 school year.

 District/charters partnered with one of the <u>NACEP-accredited institutions on this</u> <u>list</u> do not need to complete an application to receive concurrent enrollment aid.



Working with students with diverse academic, social, and emotional needs requires specialized knowledge and can be emotionally demanding, so hiring the right person is

essential. Special education teachers also manage IEPs, establish ongoing relationships with specialists, and communicate with families, all of which require the right support.

To attract and retain special education teachers, schools can show they are able to provide what these teachers need to thrive in their roles.

Join this webinar with expert Ingrid Wulczyn of Project IDEA to improve your school's special education teacher recruitment, hiring process, and ability to provide needed, ongoing support.

- 1. Update your school's COVID-19 policies and procedures. Ensure you have sufficient sanitation supplies, masks, and plans to address potential outbreaks.
- 2. Solidify transportation logistics, including bus routes and safety measures. Also, assess your staffing needs, especially if unexpected challenges arise, such as special education requirements or unexpected student enrollment.
- 3. Consider hiring or ensuring you have a competent financial team member who understands the unique funding challenges faced by charter schools.
